The timeline between the pre-bid and the bids being due is six days. Typically there is a longer period to put a bid together after a walkthrough. Is there a chance to move the due date back to give bidders more time? NO DUE TO STRICT TIMELINE RESTRAINTS WE ARE UNABLE TO CHANGE ANY DUE DATES.

- Questions are due at 4pm on the same day as the walkthrough. We generally have a team of people looking at the RFP, and although the RFP is very thorough the walkthrough generally raises a number of questions as we customize a bid that is well suited for South Bend Community School Corporation. Is there some flexibility on the question deadline? WRITTEN QUESTIONS ARE DUE AT 4PM ON JULY 29, 2019, HOWEVER YOU CAN BRING ANY QUESTIONS TO THE PRE-BID MEETING AT 10AM ON JULY 30, 2019.
- The RFP states that the pre-bid is at 10am on the 30th at the Administration Building, but also states that a walkthrough will be conducted at 9am on the 29th at Jefferson School Building. Is this the only building that will be toured? Generally the tour would consist of a number of site visits THE BUILDING TOURS WILL BEGIN AT 9AM AT THE JEFFERSON SCHOOL BUILDING, HOWEVER WE WILL ALSO VISIT 3 OTHER LOCATIONS AT THAT TIME. SBCSC IS TRYING TO GET TRANSPORTATION SET UP TO TAKE ALL INTERESTED VENDORS TO EACH LOCATION. ALL VENDORS MUST MEET AT THE JEFFERSON SCHOOL BUILDING TO BEGIN THE TOUR AT THAT LOCATION.
- The RFP stated there will be no food presentations. Has any other company conducted presentations for your School Board and/or administrators in the past year? If so, would it be fair to assume that other vendors will be given the same opportunity to present their programs to the same group? YES THERE HAVE BEEN PAST PRESENTATIONS PRIOR TO THE RFP BEING ISSUED AND APPROVED BY THE STATE OF INDIANA, HOWEVER THIS INFORMATION WAS USED TO DETERMINE IF SBCSC WANTED TO GO FORWARD WITH THIS TYPE OF PROJECT. THERE WILL BE NO FUTURE PRESENTATIONS DUE TO THE STRICT TIMELINE.
