

### CORONAVIRUS (COVID-19) AND FLU SEASON INFORMATION

Due to increased concern in the community about the spread of the 2019 Novel Coronavirus (COVID-19), South Bend Community School Corporation has developed this guide so that parents/guardians have the correct information regarding what the virus is, how to protect yourself and your child, and what to do if you suspect a possible case.

COVID-19 is a new respiratory virus that was first detected in Wuhan. Hubei Province, China. It is being closely monitored by the Centers for Disease Control and Prevention (CDC).

Reported illnesses of COVID-19 have ranged from infected individuals with little or no symptoms to individuals who are severely ill and dying. Public health officials are unclear as to how COVID-19 spreads from person to person.

#### WHAT YOU SHOULD KNOW:

The symptoms include mild to severe respiratory illness with:

- Difficulty breathing

Having these symptoms alone does not mean that someone has the virus. Symptoms may appear in as few as two days or as long as 14 days after exposure. According to the CDC, the greatest risk of infection is for individuals who have traveled to Wuhan China.

These symptoms mimic flu-like symptoms and there are currently no specific treatments for COVID-19. However, preventive measures for the COVID-19 are similar to other respiratory viruses such as the flu.









#### WHAT ARE FILL SYMPTOMS?

Flu symptoms can include a cough, sore throat, fever, runny or stuffy nose, body aches, headaches, chills, and fatique. Symptoms may include vomiting and diarrhea. Some people with the flu may not experience all these symptoms.

#### WHAT IF MY CHILD HAS THESE SYMPTOMS?

- · You should contact your healthcare provider immediately. Don't wait for symptoms to
- · Parents/guardians are encouraged to keep children home when sick.

#### WHAT ARE SOME WAYS I CAN PROTECT MY CHILD?

- According to the CDC, proper hand-washing with soap and water is one of the best ways to prevent illness.
- Demonstrate proper hand-washing for 20 seconds. Have your child visit https://www.cdc.gov/ hand-washing/index.html to watch a video on proper hand-washing.
- Demonstrate to your child how to cover their nose and mouth with a tissue when coughing or sneezing. They should throw the tissue away after use and wash their hands. If a tissue is not available, THEY SHOULD NOT USE THEIR HANDS. They should cover their mouth and nose with their sleeve.
- · Children should avoid touching their eyes, nose, or mouth. Germs spread this way.
- · Clean and disinfect frequently touched surfaces

#### **Additional Protocols for Illness:**

- Disinfect common contact surfaces
- Install hand sanitizer dispensers at entry ways
- Supplied all classroom teachers with disinfectant spray bottle
- Equipment prepped for large scale disinfection with hospital grade products
- Additional supplies on hand as needed
- Handwashing signs posted in restrooms
- Principals and custodial staff educated on cleaning procedures
- Buildings divided up into sections. Custodians follow written checklist. Turn in the written checklist into principals each day
- Special focus on Kindergarten, Pre-K, high risk populations
- Authorized additional time for employees to complete additional procedures
- Clean and wipe down all buildings over the March 12,13,14 weekend
- Buses will be misted and additionally wiped down on March 13 weekend

We want to keep you updated about our continued efforts to address the outbreak of COVID-19. Our top priority is talking care of our patients, care teams and partnering with our clients to guide employees through this ever-evolving situation.

We encourage you to communicate with your employees and members about what to do if they are.

We encourage you to communicate with your employees and members about what to do if they a experiencing symptoms related to COVID-19 and how their Activate Healthcare provider can help:

- If they are experiencing mild symptoms (cough or fever) they should first call their Activate Health
  growled for guidance on what to do next. This may include how to get texted and what locations are
  providing testing in each state. There are different testing options but the most likely will be a swab of
  the back of your nose or mouth. While current tests it typically takes 3-4 days receive test results;
  someone tests positive for the virus, they should work with their Activate Health provider to discuss
  next stress and device a pulse of case.
- If they are experiencing severe symptoms related to COVID-19 such as inability to breathe or high fever, they should go directly to the hospital or call 911.

We are aware there may be visits to our clinics by individuals exposed to or infected with the virus. The clinical teams are taking this possibility very seriously and have implemented necessary measures to prevent the spread of the virus:

- Providing masks for patients who presents in the clinic with symptoms of cough, fever and shortness of breath; placing patients experiencing symptoms in an exam room immediately and ensuring a plan for testing and care is created as soon as nossible.
- · Elevating clinic cleaning procedures:
  - Deep cleaning of exam rooms after each patient visit.
  - Use of a detergent or soap and water prior to disinfection
  - Use of diluted bleach solutions, alcohol solutions with at least 70% alcohol, and EPA-registered household disinfectants for continual disinfection activities.

It's important to remember that contracting the COVID-19 vinus is low risk for developing severe complications. In fact, 80% of those who contract the vinus have either mild or no symptoms. Most of the population will not be affected (or only milduly affected), as the virus runs its course. Saying this, there are standard precautions we should all take:

- Wash your hands often with soap and water for at least 20 seconds, especially after blowing, your nose, coughing, or sneezing; going to the bathroom; and before eating or preparing food.
- coughing, or sneezing; going to the bathroom; and before eating or preparing food.

  Avoid touching your eyes, nose, and mouth with unwashed hands.
- Stau home when you are significant.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.

We will continue to update our policies and procedures as needed, based on the most <u>up to date disease</u> protocol and <u>updatelines</u> from the CDC and state Departments of Health. 

### eLearning Adjustments Due to Illness

#### Full guidelines available at sb.school/elearning

#### **Devices**

- Grade 6-12: Students take home devices. Primary instruction is via E-Learning.
- Grade 3-5: Chromebooks coming out of the supported lifecycle are identified in buildings by DIS and building staff for student use at home. Primary instruction is via E-Learning, paper packets are provided for those without internet access.
- Grade K-2: Primary instruction is via E-Learning, paper packets are provided for those without internet access.

#### **Access**

- Students will not be expected to find access in public spaces such as libraries or community centers
- 9-12 grade students were offered internet hotspots through the Sprint 1Million Project

#### Content

- Websites for eLearning content available on the <u>South Bend EdTech website</u>. Teachers curate and select web activities from available material and sites
- Video interaction:
  - <u>Flipgrid</u> enables student discussions to happen at different times

### **Academics**

- eLearning plan will support students who have 1:1 devices (intermediate and high school campuses)
- Students who have access to devices and internet availability will be able to complete eLearning instruction planned and support from their teacher
- 3rd-5th grade students in need will be given chromebooks to use at home
- Students without devices in their home and who are not assigned a device (K-2) will be provided instructional materials to support their learning while face-to-face school is suspended
- Materials will be aligned to core curriculum and Indiana Academic Priority Standards
- State testing windows will be extended in the case of school or district closures

## **Testing Updates**

- IREAD-3 and ISTEP FTA windows have been suspended
- The IDOE is coordinating with the Governor's office and the U.S. Department of Education on broader testing forgiveness. We anticipate most standardized testing windows will be cancelled.
- We will await further guidance regarding the impact on graduation requirements.
- We will coordinate with the College Board regarding impact on upcoming SAT administrations



### **Athletics**

IHSAA Statement on COVID-19 (Coronavirus) The Indiana High School Athletic Association, Inc. is aware of the case of COVID-19 in Marion County, IN that was reported the morning of March 11. We will continue to monitor the developments and listen to medical experts and if it becomes necessary to make adjustments to high school sporting events, we will work with our member schools to take every precaution to ensure a healthy and safe environment for everyone involved. (This statement was released March 6th, 2020)

As for SBCSC sponsored athletic events, we will continue to follow directions given to the corporation by the Health Department and act accordingly.

## Athletics - IHSAA Spring Sports Update

#### IHSAA Spring Sports Update (March 13, 2020)

- Regular season contests are conducted at the discretion of our member schools. Currently, the
  guidance being provided by the State of Indiana allows for events with less than 250 individuals in
  attendance to be conducted. Local jurisdiction shall prevail with regard to whether contests in the
  regular season are conducted.
- Some schools in our state have closed and will implement extended break periods. Once students
  return to school, all provisions of Rule 9-14 Practice Attendance to Participate in a Contest shall be
  enforced. This health and safety measure within the by-laws will not be waived. Should a previously
  scheduled contest fall before the completion of said separate days of practice, the contest must be
  rescheduled or cancelled.
- A decision on meeting a minimum number of contests to become eligible for IHSAA tournament series events will be made at a later date.
- At this time, the IHSAA is planning on staging all spring sport tournament series events as scheduled.



### Athletics/Extracurricular Activities

 All district extracurricular activities and sporting events, and competitions are canceled until further notice.



### **Human Resources**

Payroll - Payment for Paraprofessionals, Bus Drivers, Service Center, Food & Nutrition Workers, building engineers, etc.

- If the School Board passes a resolution to authorize payment to employees during emergency closure, then all employee groups will paid their usual wages.
- Administration will then determine which employee groups are essential to continue the daily educational process and regular district operations for students.
  - Teachers and other certified staff will continue following e-learning protocol and are considered to be working at this time.
  - Central office staff, campus administrators, and some other staff will continue reporting to work as usual.
  - Emergency leave will compensate non-certified employees who do not have job responsibilities under extended e-learning.
- On the district side, we will determine a procedure for calculating, then entering time for payroll purposes.

To ensure a smooth transition and operational efficiency, ALL Central Office Staff will report to work. Guidance will come from your Chief/Supervisor.

### **Human Resources**

Board of Health recommends that our employees first go to their primary care provider instead of the emergency room.

Should an employee be told to stay home by a physician due to symptoms, they will need to take a sick day. After sick days are exhausted, they will need to refer to the Family and Medical Leave Act.

Should an employee test positive for the Covid-19 virus, upon returning back to work all necessary documents and physician sign-off will be required.

### Travel Guidelines

- The district requests that if students are traveling out of the country, or to an area of the U.S.
   that is known to have coronavirus, parents/guardians should notify the school principal.
- The district requests that if staff members are traveling out of the country, or to an area of the U.S. that is known to have coronavirus, they should notify their immediate supervisor.
- The district is suspending all employee conference travel until the end of the school year.
